21 COUNT ONE: (18 U.S.C. § 1112 – Involuntary Manslaughter)

22 On or about April 4, 2023, in the Northern District of California, within the boundaries of an area
23 administered by the Presidio Trust, the defendant,

24 ARNOLD KINMAN LOW,

25 did unlawfully kill E.B. without malice, in the commission of an unlawful act not amounting to a felony,
26 that is, operating a motor vehicle while under the influence of alcohol to a degree that rendered the
27 defendant incapable of safe operation, in violation of Title 18, United States Code, Section 1112, a Class
28 D felony.

INDICTMENT

1 COUNT TWO: (36 C.F.R. § 1004.23(a)(1) – Operating Under the Influence of Alcohol)

2 On or about April 4, 2023, in the Northern District of California, within the boundaries of an area
3 administered by the Presidio Trust, the defendant,

4 ARNOLD KINMAN LOW,

5 did unlawfully operate and was in actual physical control of a motor vehicle while under the influence of
6 alcohol, to a degree that rendered the defendant incapable of safe operation, in violation of Title 36,
7 Code of Federal Regulations, Section 1004.23(a)(1), a Class B misdemeanor.
